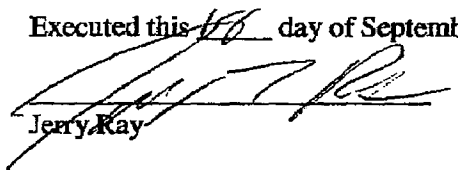
ASSIGNMENT OF APPLICATION
