
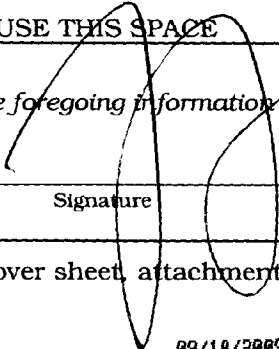
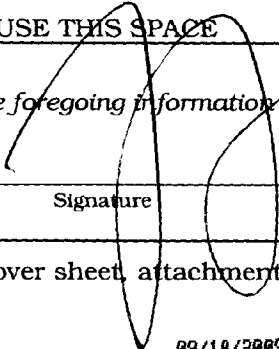
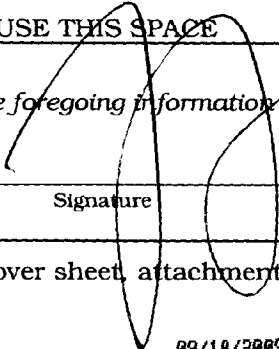

CERTIFICATE

The undersigned:

I, Cornelis Jan Kraalveld, *kandidaat-notaris* (candidate civil law notary), acting as a substitute for Johannes Daniël Maria Schoonbrood, *notaris* (civil-law notary), practising in Amsterdam, the Netherlands,

herewith certifies that:

- (i) the private company with limited liability **Microtronic Nederland B.V.**, number B.V.: 535.462, number Dutch trade register: 33269435 (the "**Company**") was incorporated under the laws of the Netherlands on 19 July 1995 by means of a notarial deed, executed before a substitute of Martinus Adrianus Jurjen Marie Scholtens, at the time *notaris* in Amsterdam, the Netherlands (the "**Deed of Incorporation**");
- (ii) on 25 March 2002, the name of the Company was changed to **SonionMicrotronic Nederland B.V.** by means of a notarial deed amending the Company's articles of association, executed before Arnout Christiaan Stroeve, at the time *notaris* in Amsterdam, the Netherlands (the "**Deed of Amendment 1**");
- (iii) on 20 November 2003, the name of the Company was changed to **Sonion Nederland B.V.** by means of a notarial deed amending the Company's articles of association, executed before Arnout Christiaan Stroeve, aforementioned (the "**Deed of Amendment 2**");
- (iv) on 23 December 2008, the Company ceased to exist pursuant to a legal merger with the private company with limited liability **Pulse Nederland B.V.**, number B.V.: 1.459.381, number Dutch trade register: 34287738, effected by a notarial deed of merger, executed on 22 December 2008 before Alexander Andriaen van Velten, at the time *notaris* in Amsterdam, the Netherlands (the "**Deed of Merger**"), whereby the Company was the disappearing company and Pulse Nederland B.V. was the acquiring company.

When issuing the statements included above under (i) through (iv) I based any observations exclusively on copies of the Deed of Incorporation, the Deed of Amendment 1, the Deed of Amendment 2 and the Deed of Merger, which have been provided to me by the Dutch Trade Register and are attached to this certificate.
