FIRST: That the Board of Directors of the Corporation, by written consent in lieu of a meeting on February 28, 2008, in accordance with the provisions of Sections 141(f) and 242 of the General Corporation Law of the State of Delaware, duly and validly adopted resolutions setting forth a proposed amendment to the Certificate of Incorporation of the Corporation. The resolutions setting forth the proposed amendment are as follows:

RESOLVED: That it is advisable and in the best interests of the Corporation to change the name of the Corporation as set forth below.

RESOLVED: That Article I of the Third Amended and Restated Certificate of Incorporation of the Corporation be, and hereby is, deleted in its entirety and the following Article I be inserted in lieu thereof:

"The name of this corporation is EveryScape, Inc."

SECOND: That the aforesaid Charter Amendment was duly adopted by written consent of the stockholders of the Corporation in accordance with the provisions of Sections 228 and 242 of the General Corporation Law of the State of Delaware.
