

RECITALS


- A. The ASSIGNOR is the proprietor and/or beneficial owner of the patents identified in the Schedule A hereto (hereinafter referred to as "the said patents").
- B. In consideration of the sum of one dollar New Zealand currency (NZ\$1.00) paid by the ASSIGNEE to the ASSIGNOR (payment and sufficiency of which the ASSIGNOR acknowledges) and other good and valuable consideration the ASSIGNOR assigns and transfers over unto the ASSIGNEE for all countries of the world its whole right, title and interest in and to the said patents unto and to the use of the ASSIGNEE and including all intellectual property rights residing in the said patents and in original works relating thereto including but not limited to copyright and all other rights of a like nature of which the ASSIGNOR is the legal or beneficial owner in respect of or associated with the said patents and including the right to apply for corresponding patents in any other country and including all rights, if any, of the ASSIGNOR to take actions against third parties for infringement of the patents whether or not such infringement took place prior to the date of this Deed, unto and to the use of the ASSIGNEE its successors and assigns absolutely.

AND FURTHER PROVIDED THAT

The ASSIGNOR hereby undertakes to do any reasonable acts at the request and expense of the ASSIGNEE as may be necessary to give effect to the assignment of the said patents and to facilitate the filing, obtaining, maintenance or enforcement of protection therefor in the name of the ASSIGNEE.
