MLM ASSIGNMENT

WHEREAS, Multi Level Memory Technology, a Nevada corporation has its principal place of business at 1281 Terminal Way, Reno, NV (hereinafter "Assignor");

WHEREAS, Assignor is the owner, by assignment or otherwise, of U.S. Patent No. 6,937,520 titled "Nonvolatile Semiconductor Memory Device" issued on August 30, 2005 ("the '520 patent"), including without limitation, its corresponding foreign patents and applications, any and all renewals, divisions, continuations (in whole or in part), or continued prosecution applications relating to such patents and patent applications, any and all reissues, reexaminations, extensions, divisions, renewals, substitutions, confirmations, registrations, revalidations, revisions and additions of or to any of such patents and patent applications, and any other patents and applications that rely on such patents and patent applications for priority, and any and all inventions conceived, reduced to practice by, on behalf of, or assigned to MLM relating to the foregoing and all foreign equivalents, continuations, divisionals, and continuations-in-parts, including pending Japanese Application No. 2004-215532 (also published as JP 2005-216466) (hereinafter referred to in total as "the Assigned Patents");

Ltd., a Korean corporation having a business address at 416 Mactan-dong, Yeongtong-gu, Suwon-si, Gyeonggi-do, Republic of Korea ("Samsung" or "Assignee") desires to acquire MLM's entire right, title and interest, including the right of priority, in, to and under the Assigned Patents.

NOW, THEREFOR, for good and valuable consideration, which is hereby acknowledged, MLM ("Assignor") hereby sells, assigns, and transfers to Samsung, MLM's entire right, title, and interest in, to and under the Assigned Patents.

MLM does hereby grant to Samsung the sole and exclusive right to sue for past infringement of the Assigned Patents, including the right to all past damages. The final decision whether or not a particular party is to be sued lies solely with Samsung. Samsung will have sole control of such suits, shall bear all cost and expenses of such suits and shall be entitled to all proceeds from such suits.

Assignor further agrees to execute all papers useful in connection with said United States and foreign applications, and generally to do everything possible to aid Assignee, its successors, assigns, and nominees, at their request and expense, in obtaining and enforcing patents for the inventions in all countries. Assignor requests the Commissioner of Patents and Trademarks to issue all patents granted for said invention to Samsung Electronics Co. Ltd., its successors, assigns, and nominees.
