## ASSIGNMENT

WHEREAS, I, Bester Jacobus Pansegrouw, a citizen of South Africa, (hereinafter referred to as "ASSIGNOR"), am the sole inventor of certain new and useful improvements in INFLATION DEVICE (hereinafter referred to as "INVENTION"), for which an application for United States Letters Patent was filed on August 27, 2009, under Serial No. 12/548,818, and which application claims priority from an international application filed on March 3, 2009, under Serial No. PCT/IB2009/050851, which itself claims priority from a South African application filed on March 3, 2008, under Serial No. ZA2008/02055, all applications listed above being hereinafter referred to as the "APPLICATION"; and

WHEREAS, Stopak (Pty) Ltd., a South African corporation (hereinafter referred to as "ASSIGNEE"), having a principal place of business at 4 Paddy Close, Ottery, South Africa, 7908, has acquired the equitable right, title, and interest—and is desirous of acquiring any remaining right, title, and interest—in and to said INVENTION as described in said provisional application, and in and to any and all Letters Patent that shall be granted with respect to said invention in the United States of America and all foreign countries;

NOW, THEREFORE, be it known that for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, I, the ASSIGNOR, have sold, assigned, transferred, and conveyed unto said ASSIGNEE, its successors and assigns, my equitable right, title, and

interest—and by these presents do hereby sell, assign, transfer, and convey unto said ASSIGNEE, its successors and assigns any remaining right, title, and interest—in and to said INVENTION, in and to said provisional application, in and to any and all non-provisional applications claiming benefit of the filing date of said provisional application, and in and to any and all Letters patent of the United States of America and all foreign countries or reissues thereof that may be granted therefore or thereon, for the full term for which said Letters Patent may be granted, together with the right to claim the priority of said provisional application in all foreign countries in accordance with international treaties and conventions, the same to be held and enjoyed by said ASSIGNEE, its successors and assigns, as fully and entirely as the same would have been held and enjoyed by me if an assignment and sale had not been made.



I further acknowledge that said ASSIGNEE has the sole right to determine patent prosecution strategies with respect to said INVENTION and all corresponding applications, and hereby request that Letters Patent be issued in accordance with this assignment.

I further covenant and agree to bind my heirs, legal representatives, and assigns, promptly to communicate to said ASSIGNEE or its representatives any facts known to me relating to said INVENTION, to testify in any interference or legal proceedings involving said INVENTION, to execute any additional papers that may be requested to confirm the right of the ASSIGNEE, its representatives, successors or


