"ACTIVATED PROTECTIVE FABRIC"

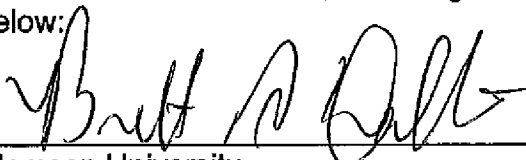
