whose address is 1018 New Holland Ave., Lancaster, PA 17601

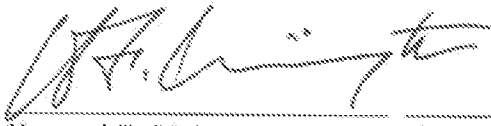
