## ASSIGNMENT

WHEREAS, We, **William R. Levis**, a United States citizen, residing at 252 7th Avenue, Apt. 3X, New York, New York 10001, and **Frank T. Martiniuk**, a United States citizen, residing at 174 Woodridge Street, Wood-Ridge, New Jersey 07075, have invented certain new and useful improvements in **HEAT SHOCK PROTEINS FROM MYCOBACTERIUM LEPRAE AND USES THEREOF** for which we have executed an application for Letters Patent in the United States, filed as U.S. Serial No. 11/523,215 on September 19, 2006;

AND WE HEREBY covenant and agree that we will communicate to the said **New York University**, its successors, legal representatives and assigns, any facts known to us respecting said improvements and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the said **New York University**, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.


