ASSIGNMENT

WHEREAS, We, Amit Lal, a US citizen, residing in Ithaca, New York and Shankar Radhakrishnan, a citizen of India, residing in New York, New York have invented certain new and useful improvements in ALKALI METAL-WAX MICROPACKETS FOR ALKALI METAL HANDLING for which an application for Letters Patent in the United States was filed as U.S. Serial No. 11/447,201 on June 6th, 2006; claiming priority to U.S. Provisional Application No. 60/687,306 on June 6th, 2005;

AND WE HEREBY covenant and agree that we will communicate to the said **Cornell University**, its successors, legal representatives, and assigns, any facts known to us respecting said improvements and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing, and reissue applications, make all rightful oaths and generally do everything possible to aid the said **Cornell University**, its successors, legal representatives, and assigns, to obtain and enforce proper patent protection for said improvements in all countries.
