GENERAL ASSIGNMENT OF PATENTS AND PATENT APPLICATIONS

THIS GENERAL ASSIGNMENT OF PATENTS AND PATENT APPLICATIONS ("Assignment") is entered into this 2nd day of October, 2009, by and between Kevin Tyson Brittingham, an individual residing in Georgia ("Inventor"), having an office at 1434 Hillcrest Road, Norcross, GA 30093, and AAC Acquisitions, LLC, a Delaware limited liability company, and their heirs or assignees ("Buyer"), having an office at 870 Remington Drive, PO Box 700, Madison, NC 27025.

WHEREAS, this Assignment is a condition of closing the purchase of substantially all of the assets, and the assumption of certain liabilities, of Advanced Armament Corporation ("AAC"), including assets used in the manufacture, distribution and sale of silencers sold by AAC, by Buyer pursuant to an Asset Purchase Agreement, dated as of the date hereof, by and between AAC and Buyer; and

WHEREAS, Inventor is the owner of certain patents and patent applications listed in Schedule A ("Patents and Patent Applications"), relating to silencers, flash suppressors, and other firearm technology; and

WHEREAS, Inventor desires to assign to Buyer all Patents and Patent Applications described above and Buyer desires to accept the assignment thereof.

NOW, THEREFORE, for and in consideration of the mutual covenants contained herein and other good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, Inventor hereby irrevocably assigns and transfers to Buyer all of Inventor's right, title and interest in, to and under the Patents and Patent Applications, as well as any patents which may be granted based upon the Patent Applications, as the same shall exist on the date hereof, TO HAVE AND TO HOLD the same unto Buyer, its successors and assigns, forever.

Inventor hereby constitutes and appoints Buyer the true and lawful attorney of Inventor, with full power of substitution, in the name of Buyer, but on behalf of and for the benefit of Buyer: (i) to demand and receive from time to time the Patents and Patent Applications and to make endorsements and give receipts and releases for and in respect of the same and any part thereof; (ii) to institute, prosecute, compromise and settle any and all proceedings that Buyer may deem proper in order to collect, assert or enforce any claim, right or title of any kind in or to the Patents and Patent Applications; (iii) to defend or compromise any or all proceedings in respect of any of the Patents and Patent Applications; and (iv) to do all such acts and things in relation to the matters set forth in the preceding clauses (i) through (iii) as Buyer shall deem desirable. Inventor hereby acknowledges that the appointment hereby made and the powers hereby granted are coupled with an interest and are not and shall not be revocable by him in any manner or for any reason. Buyer shall indemnify and hold Inventor harmless from any and all losses caused by or arising out of any breach of law by Buyer in its exercise of the aforesaid powers.

This Assignment may be executed in any number of counterparts, each of which will be deemed an original, but all of which together will constitute one and the same instrument.

This Assignment shall be governed by and construed in accordance with the laws of the United States of America applicable to Patents.

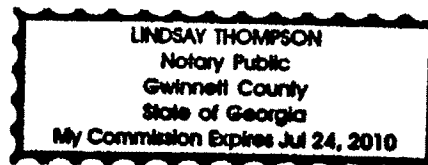

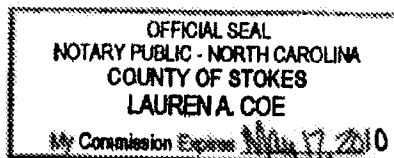
