## PATENT RIGHTS ASSIGNMENT

THIS AGREEMENT, entered into this 13 day of June 2007, is by and between the following parties:

Jerald J. Riopel, of the State of Minnesota, U.S.A. (hereinafter "ASSIGNOR")

and

Seth Michael Brittain and Dawn Christine Brittain of the State of Minnesota, U.S.A. (hereinafter "ASSIGNEE")

WHEREAS, ASSIGNOR owns an indivisible interest in U.S. Patent 7,175,033 b1 issued on July 29, 2004, and entitled "Portable chafing stand system" including any reexaminations, reissues, continuations, or divisions thereof (hereinafter the "PATENT");

WHEREAS, ASSIGNOR has agreed, pursuant to a share purchase agreement dated June 13, 2007, (the "Share Purchase Agreement") to transfer his interest to ASSIGNEE; and

WHEREAS, ASSIGNEE wishes to acquire all right, title, and interest to the PATENT.

NOW, THEREFORE, the parties agree as follows:

1. **GRANT OF ASSIGNMENT.** ASSIGNOR, pursuant to the Share Purchase Agreement, agrees to assign and hereby does assign and convey all right, title, and interest in the PATENT to ASSIGNEE, including all income, royalties, damages, and payments now or hereafter due or payable with respect thereto, and all causes of action (either in law or in equity) and the right to sue, counterclaim and recover for past, present and future infringement of the rights assigned or to be assigned under this Agreement.

2. **REPRESENTATIONS AND WARRANTIES.** ASSIGNOR represents and warrants that Assignor has made no other assignments of its right, title, and interest in the patent, other than the Assignment set forth in Paragraph 1 in this Agreement. ASSIGNOR further

represents and warrants that it has not granted any exclusive or non-exclusive license or licenses in the PATENT.

3. **NOTICE OF REGISTRATION.** ASSIGNEE shall file and record such documents necessary to perfect its interest in and to the Patent with the United States Patent and Trademark Office, all costs to be born by ASSIGNEE. ASSIGNOR agrees to sign all such documents.

4. **ENTIRE AGREEMENT.** This Agreement contains the entire Agreement between the parties hereto and supercedes and cancels all previous agreements, negotiations, commitments and writings in respect to the subject matter hereof, and may not released, discharged, abandoned, changed or modified in any manner, orally or otherwise.

5. **GOVERNING LAW.** This Agreement shall be interpreted and construed and the legal relations created herein shall be determined with accordance with the Laws of the State of Minnesota.




