THIS ASSIGNMENT is dated 27th July 2009

PARTIES

- (1) **FIBRA LIMITED** incorporated and registered in England and Wales with company number 4589830 whose registered office is at 19 Horseshoe Park, Horseshoe Road, Pangbourne, Berkshire RG8 7JW ("**Assignor**").
- (2) **SHELL TECHNOLOGY VENTURES FUND 1 BV** incorporated and registered in The Netherlands whose registered office is at Lange Kleiweg 60F, 2288 GK, Rijswijk, The Netherlands ("**Assignee**").

BACKGROUND

- (A) The Assignor is the proprietor of or applicant for the patents and applications therefor listed in the Schedule to this Assignment
- (B) The Assignor entered into a Licence Agreement with Shell Research Limited dated 27 November 2008 (the "**Licence Agreement**")
- (C) On 9th March 2009 the Assignor issued to the Assignee £827,880 nominal amount of sterling convertible loan notes (the "**Loan Notes**") which continue to be held by the Assignee
- (D) The Assignor has agreed to assign to the Assignee the Patents and the Assignor's rights and benefits under the Licence Agreement and the Assignee has agreed to accept such assignment in full and final satisfaction of all monies and other obligations arising under the Loan Notes

AGREED TERMS

1. INTERPRETATION

In this Assignment:

"**Patents**" means:

- (a) the patents and applications therefor, details of which are set out in Schedule 1,
- (b) all other patents and applications therefor of which the Company is the proprietor or applicant;
- (c) all divisionals, continuations, continuations-in-part, substitutes, extensions and reissues of any of the foregoing; and
- (d) all filings in any country claiming priority from any of the foregoing, and all foreign counterparts of any of the foregoing.

2. ASSIGNMENT

In consideration of the sum of £827,880 to be satisfied by the cancellation of the Loan Notes and the waiver of all accrued but unpaid interest on the Loan Notes, the Assignor hereby assigns to the Assignee with full title guarantee:

- 2.1 all its right title and interest in the full and exclusive benefit of the Patents including:
 - (e) the right to recover and take all proceedings for the recovery of damages or otherwise in respect of all infringements of any of the Patents, whether committed before or after the date of this Assignment;
 - (f) the absolute entitlement to any patent granted pursuant to any of the applications comprised in the Patents, for the full term of such patent; and
 - (g) the Assignor's right to apply for, prosecute and obtain a patent or similar protection in the United Kingdom and all other countries in the world for any invention embodied in any of the Patents, including the right to claim priority from any Patent; and
- 2.2 all its rights and benefits (but not its obligations) under the Licence Agreement which the Assignor is free to assign to STVF1 without the consent of Shell Research Limited.

3. FURTHER ASSURANCE

The Assignor hereby covenants with the Assignee that the Assignor shall, at the expense of the Assignee, execute and sign all such instruments, applications and documents and do all such acts and things as may reasonably be required by the Assignee to enable the Assignee or its nominee to enjoy the full benefit of the rights assigned by this Assignment.

4. GOVERNING LAW AND JURISDICTION

- 4.1 This Assignment and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) shall be governed by and construed in accordance with English law.
- 4.2 The parties irrevocably agree that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this Assignment or its subject matter or formation (including non-contractual disputes or claims).

This Assignment has been executed as a deed on the date stated at the beginning of it.






