REASSIGNMENT AND RELEASE OF SECURITY INTEREST

This Reassignment and Release of Security Interest is made as of October 15, 2009 by COMERICA BANK, a Texas banking association, as successor in interests to IMPERIAL BANK, a California banking corporation ("LENDER") to ASPECT MEDICAL SYSTEMS, INC., a Delaware Corporation, with its principal place of business at One Upland Road, Norwood, Massachusetts 01810 ("COMPANY").

Recital

WHEREAS, COMPANY has satisfied all its obligations to LENDER in the Security Agreements, and LENDER wishes to reassign all interest that LENDER may have in the Patents.

Now Therefore, LENDER agrees that it releases its security interest in the Patents and reassigns to COMPANY, without warranty or recourse, all interest of LENDER in the Patents.
