THIS ASSIGNMENT is made on the 15th day of October, 2009

BETWEEN

and

(2) Eric Beare Associates Limited, a limited liability company incorporated under the laws of Hong Kong Special Administrative Region of ROOM 1202-4, NEW KOWLOON PLAZA, 38 TAI KOK TSUI ROAD, KOWLOON, HONG KONG ("The Assignee")

WHEREAS

- (A) The Assignor created a design for a Magnetic Memo Board ("the Design"). Representations of the Design are annexed hereto in Attachment A.
- (B) The Assignor has agreed to assign all rights in the Design to the Assignee on the terms set out herein and to execute this Assignment.

IT IS AGREED as follows:

1. In consideration of the sum of HK\$1 (receipt of which the Assignor hereby acknowledges), the Assignor as beneficial owner hereby sells, assigns and transfers to the Assignee the full and entire rights, title and interests in the Design for which an application for United States Patent was executed on the date hereof and may be granted therefor, to the full end of the term for which the said patent may be granted, as fully and entirely as the same would have been held by the Assignor had this Assignment not been made, together with the right to sue for past infringements of any such right and to retain any damages obtained as a result of such action.
2. This Assignment shall be governed by and construed in accordance with the laws of Hong Kong Special Administrative Region and the parties hereby submit to the non-exclusive jurisdiction of the courts of Hong Kong Special Administrative Region.

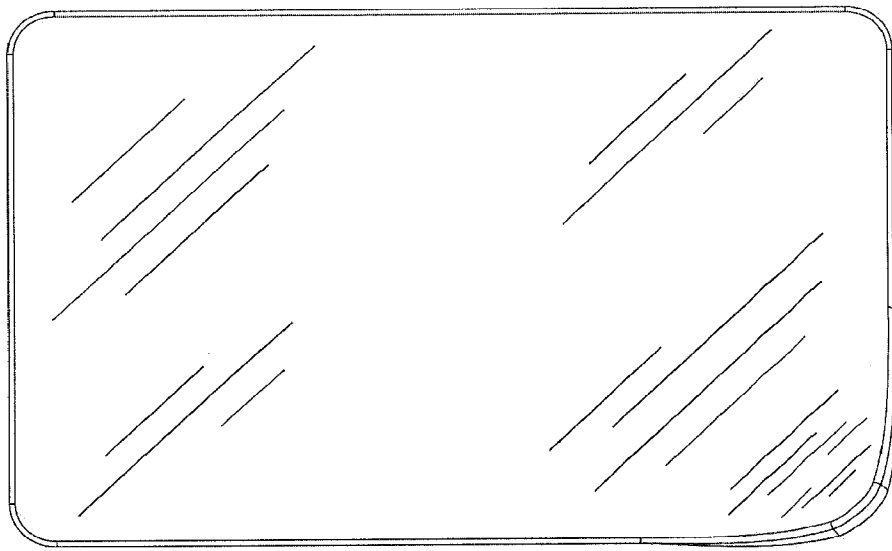

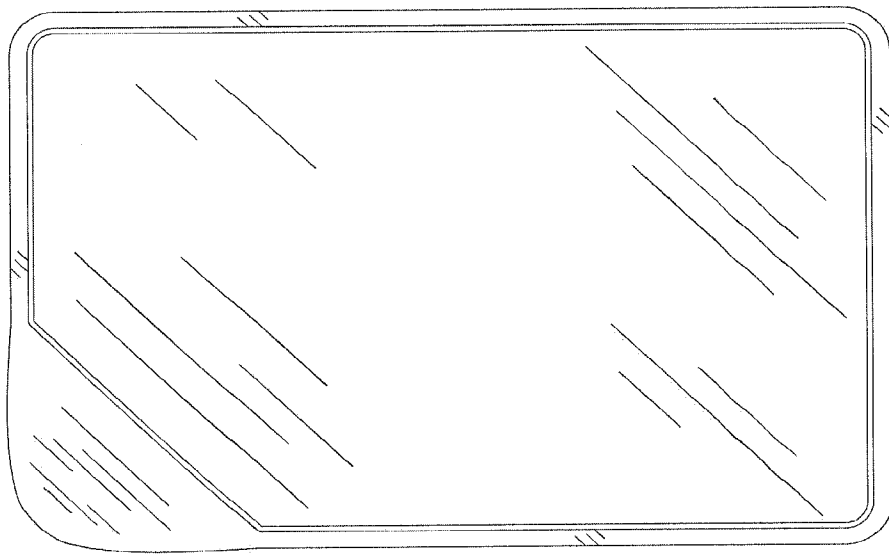

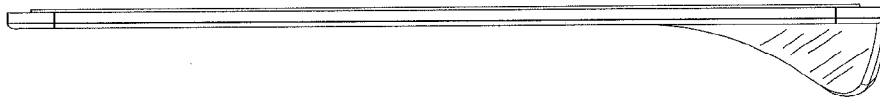

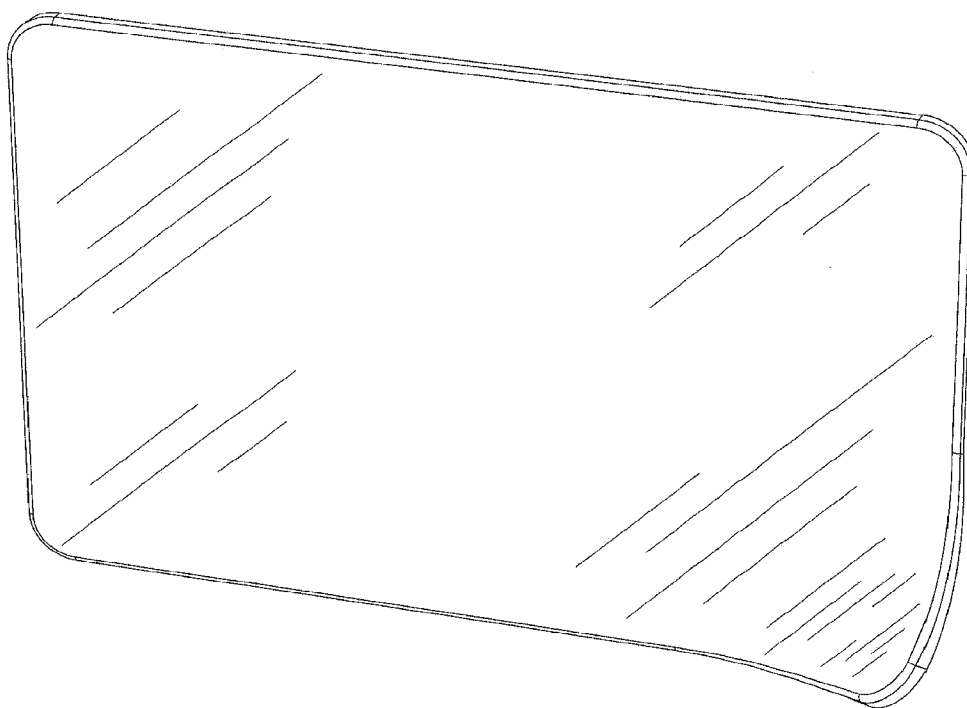

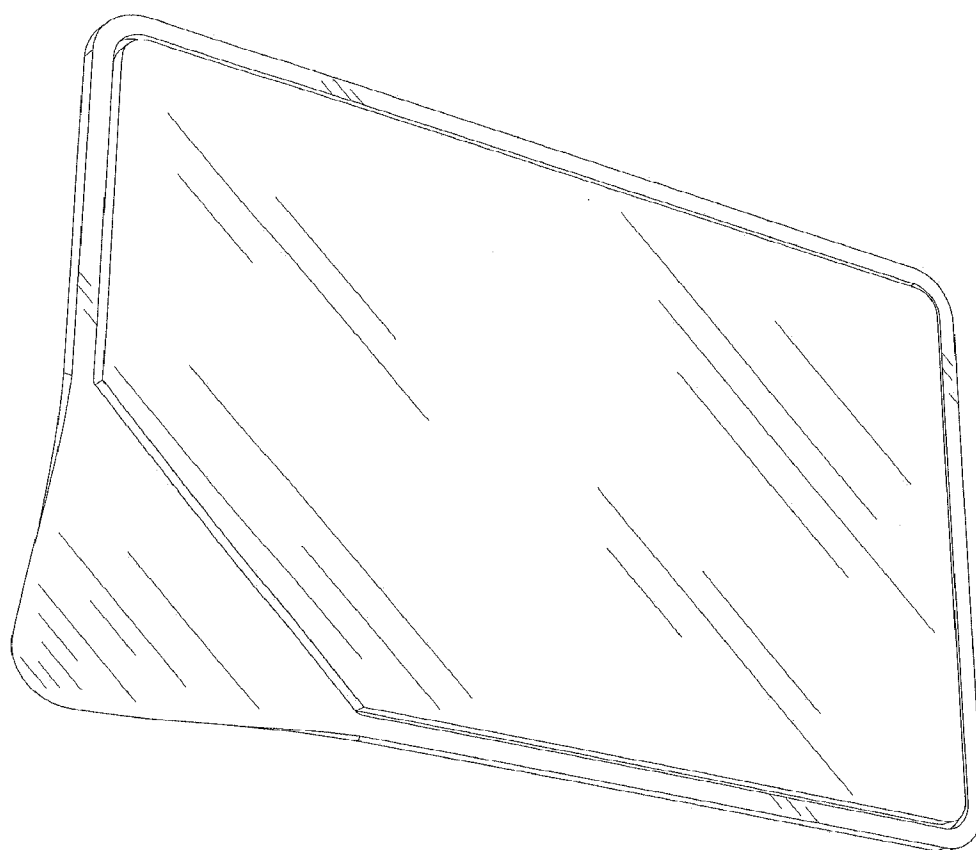
