AND I HEREBY AUTHORIZE AND REQUEST the Commissioner of Patents or the Comptroller (as the case may be) to issue any and all Letters Patent for said invention, or resulting from said application, or from any division, re-issue, or extension thereof, to the Assignee as the sole assignee.
