FRONT-END PART OF A MOTOR VEHICLE WITH AN AIR-GUIDING ELEMENT

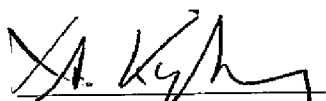

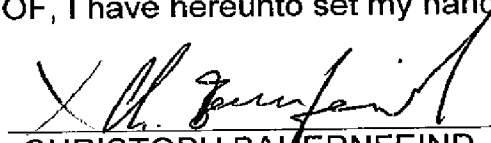
