PATENT TRANSFER STATEMENT
(under Uniform Commercial Code Section 9-619)

WHEREAS, CSwitch Corporation, a Delaware corporation ("CSwitch"), is the registered owner of certain patents registered and patents applications pending in the United States Patent and Trademark Office, (hereinafter collectively referred to as the "Patents" and "Applications"), all of which are set forth on the Schedule attached hereto;

WHEREAS, CSwitch previously granted to each of Venture Lending & Leasing IV, Inc. ("VLL4"), Venture Lending & Leasing V, Inc.
