WHEREAS, Roger X. Lenard, hereinafter called the "Assignor", has, along with Robert F. D'Ausilio, James R. Stuart, Thomas N. Giaccherini and Franklin H. Williams, Jr., made the invention described in the United States patent application entitled IN ORBIT SPACE TRANSPORTATION & RECOVERY SYSTEM, Application Serial No. 11/651,800, filed January 10, 2007;

WHEREAS, IOSTAR CORPORATION, a corporation organized and existing under the laws of the State of Delaware, having a place of business at 900 North 400 West, Bldg #10 North Salt Lake City, UT 84054, hereinafter called the "Assignee", desires to acquire the entire right, title and interest in and to the invention and the patent application identified above, and all patents which may be obtained for said invention, as set forth below;

WHEREAS Robert F. D'Ausilio, James R. Stuart, Thomas N. Giaccherini and Franklin H. Williams, Jr., previously executed an assignment to Intraspace Corporation for Application Serial No. 10/779,869, as inventors of that application, recorded in the Patent and Trademark Office at Reel 015789, frame 0478, covering the present application, which is a divisional of said Application Serial No. 10/779,869;

WHEREAS INTRASPACE CORPORATION subsequently changed its name to IOSTAR CORPORATION;

WHEREAS Roger X. Lenard was not originally named as an inventor of Application Serial No. 10/779,869 or Application Serial No. 11/651,800, but has now executed a declaration as a co-inventor with Robert F. D'Ausilio, James R. Stuart, Thomas N. Giaccherini and Franklin H. William, Jr., for the claims allowed in Application Serial No. 11/651,800;

NOW, THEREFORE, in consideration of valuable and legally sufficient consideration, the receipt of which by the Assignor from the Assignee is hereby acknowledged, the Assignor has sold, assigned and transferred, and by these presents does sell, assign and transfer to the Assignee, the entire right, title and interest for the United States in and to the invention and the patent application identified above, and any patents that may issue for said invention in the United States; together with the entire right, title and

interest in and to said invention and all patent applications and patents therefor in all countries foreign to the United States, including the full right to claim for any such application all benefits and priority rights under any applicable convention; together with the entire right, title and interest in and to all continuations, divisions, renewals and extensions of any of the patent applications and patents defined above; together with the right to recover all damages, including, but not limited to, a reasonable royalty, by reason of past, present, or future infringement or any other violation of patent or patent application rights; to have and to hold for the sole and exclusive use and benefit of the Assignee, its successors and assigns, to the full end of the term or terms for all such patents.



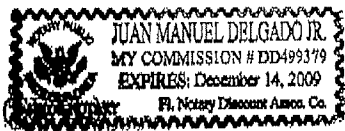
