AND I/WE HEREBY further covenant and agree that I/WE will communicate to Assignee any facts known to us respecting said ornamental design, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, continuations-in-part, substitute and reissue applications, make all rightful oaths, and generally do everything possible to aid Assignee to obtain and enforce proper patent protection for said ornamental design in all countries.
