We hereby further assign and transfer to the Assignee on the same terms and conditions as aforesaid all of our right, title and interest in and to the above-mentioned application and the invention and discoveries described therein in all other countries other than the United States of America and with effect for all multi-national organizations for the protection of intellectual property. This full assignment and transfer includes, but is not limited to, the assignment and transfer of the right to file an application for a patent or any other protective right in the Assignee's

name, and the right to claim priority to the above-identified U.S. application under the International Convention for the Protection of Industrial Property or under any other bilateral or multilateral agreement to which the United States of America is now or hereafter becomes a signatory, or any other legal provision which allows claiming the priority of the assigned application.
