ASSIGNMENT OF PATENT APPLICATION

WHEREAS, we, JEFFREY A. KROLIK, JUAN DOMINGO, DARYUSH MIRZAEI, and, JAMES H. DREHER, citizens of the United States (hereinafter referred to as “ASSIGNORS”), have invented and own a certain invention entitled FLOW RESTORATION SYSTEM AND METHODS FOR USE, for which application for Letters Patent of the United States of America was filed on SEPTEMBER 22, 2009, and assigned Serial No. 12/564,892; and

equivalent thereof, to issue said patents to ASSIGNEE, its successors and assigns, in accordance with this Assignment.






