WHEREAS I, **STEFAN STARK**, a German citizen residing at Ludwigsburg, Germany, have invented certain new and ornamental improvements in a

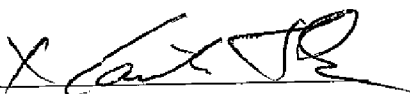
FORK LIFT
