**TERMINATION AND RELEASE
OF DEBTOR-IN-POSSESSION
SECURITY INTEREST IN PATENTS**

THIS TERMINATION AND RELEASE OF DEBTOR-IN-POSSESSION SECURITY INTEREST IN PATENTS (this "Release") is made as of October 26, 2009, from General Electric Capital Corporation, in its capacity as administrative agent and collateral agent (in such capacity, together with its successors and permitted assigns, the "Administrative Agent") for itself, the Lenders, the L/C Issuers, and each other Secured Party (as defined in the Senior Secured Priming and Superpriority Debtor-In-Possession Credit Agreement, dated as of April 22, 2009 (as the same may be amended, restated supplemented or otherwise modified from time to time, the "Credit Agreement")) to Dayton Superior Corporation ("Grantor").

WITNESSETH:

WHEREAS, pursuant to the Debtor-In-Possession Guaranty and Security Agreement dated as of April 22, 2009 (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified) in favor of the Administrative Agent (the "Guaranty and Security Agreement") and the Debtor-In-Possession Patent Security Agreement dated as of May 29, 2009, in favor of the Administrative Agent (the "Patent Security Agreement"), Grantor mortgaged, pledged and hypothecated to the Administrative Agent for the benefit of the Secured Parties, and granted to the Administrative Agent for the benefit of the Secured Parties, a Lien on and security interest (the "Security Interest") in, all of its right, title and interest in, to and under the Patent Collateral (as defined in the Patent Security Agreement);

WHEREAS, the Patent Security Agreement was recorded in the United States Patent and Trademark Office, at Reel 022757, Frame 0465 on June 1, 2009; and

WHEREAS, the Administrative Agent now desires to terminate and release the entirety of its Security Interest in the Patent Collateral;

NOW, THEREFORE, for good and valuable consideration, including the satisfaction of all obligations, indebtedness and liabilities secured by the Patent Collateral pursuant to the Patent Security Agreement, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, the Administrative Agent hereby states as follows:

1. Definitions. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Credit Agreement and the Patent Security Agreement.
2. Release of Security Interest. The Administrative Agent hereby terminates, cancels, releases, and discharges its Security Interest in the Patent Collateral including without limitation, the Patent Collateral listed in Exhibit 1 attached hereto. Any and all right, title, or interest of the Administrative Agent in, to and under such Patent Collateral and all proceeds thereof, including without limitation, the goodwill of the business connected with the use of, and symbolized by, the Patent Collateral and any and all causes of action which may exist by reason of infringement of the Patent Collateral, shall hereby cease and become void.

3. Further Assurances. The Administrative Agent hereby agrees to duly execute, acknowledge, procure, and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest in the Patent Collateral contemplated hereby.
