AOL LLC hereby authorizes and requests the Patent Office Officials in the United States and its territorial possessions and in any and all foreign countries to issue any and all of said Letters Patents, when granted, to AOL LLC and WARNER BROS. ENTERTAINMENT INC. as JOINT OWNERS of the entire right, title and interest in and to the same, for the sole use and benefit of said JOINT OWNERS, their successors and assigns, to the full end of the term for which said Letters Patents may be granted, as fully and entirely as the same would have been held by AOL LLC had this Assignment not been made.

Further, AOL LLC and WARNER BROS. ENTERTAINMENT INC. agree that each will communicate with the other or their legal representatives and assigns any facts known to them respecting said inventions, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, substitute, renewal and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patents to be issued to said AOL LLC and WARNER BROS. ENTERTAINMENT INC. as JOINT OWNERS, make all rightful oaths, and, generally do everything possible to aid said JOINT OWNERS, their successors and assigns, to obtain and enforce proper protection for said inventions in the United States and its territorial possessions and in any and all foreign countries.
