## ASSIGNMENT

WHEREAS, WE, MATHIEU LION, residing at 9 Cite Aubry, 75020 Paris, France and ELODIE BRISSET, residing at 18 rue Cavendish 75019 Paris, France, both citizens of France, have invented a new and useful design for DOUBLE-WALLED CARAFE, for which application papers for United States Letters Patent are being filed herewith; and
