

**ASSIGNMENT AND AGREEMENT**

**FOR VALUE RECEIVED, We, Lauri Aarne Johannes WIROLA**, a citizen of Finland, residing at Vestonkatu 67 F 19, 33580 Tampere, Finland and **Tommi Antero LAINE**, a citizen of Finland residing at Kirjavaisenkatu 19 B 4, 33560 Tampere, Finland, hereby sell, assign and transfer to **NOKIA CORPORATION**, a corporation duly organized and existing under the laws of Finland, and having a principal place of business at Keilalahdentie 4, FIN-02150 Espoo, Finland, as assignee, and its successors, assigns and legal representatives, the entire right, title and interest, for all countries in and to certain inventions relating to improvements in **SCREENING INFORMATION FOR A COVERAGE MODEL**, for the PCT International Application Number PCT/US2009/001430 filed March 4, 2009; and all the rights and privileges under any and all Letters Patent that may be granted therefore, including continuations and divisionals thereof.

We hereby consent that a copy of this assignment shall be deemed a full legal and formal equivalent of any assignment, consent to file or like document which may
