ASSIGNMENT

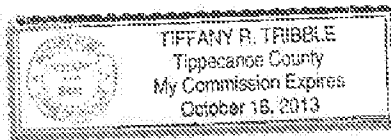



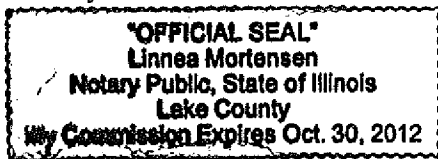
