And, Seller, hereby authorizes and requests the Commissioner of Patent and Trademarks to issue any and all Letters Patent of the United States on said inventions to Purchaser as assignee of the entire interest, and hereby covenants that Seller has full right to convey the entire interest herein assigned, and that, except as otherwise provided between the parties, Seller has not executed, and will not execute, any agreements in conflict therewith.
