

and

(2) EUMAX TECHNOLOGY (SHENZHEN) LTD., a limited liability company incorporated under the laws of the People's Republic of China of 4 FL., BUILDING 6, LIANTANG INDUSTRIAL PARK, BUJI, KANGZHENG ROAD, DANZHUTOU, BUJI, SHENZHEN, GUANGDONG PROVINCE, PEOPLE'S REPUBLIC OF CHINA ("The Assignee")

WHEREAS

- (A) The Assignor created a design for an ultrasonic cleaner ("the Design"). Representations of the Design are annexed hereto in Attachment A.

- 2. This Assignment shall be governed by and construed in accordance with the laws of the People's Republic of China and the parties hereby submit to the non-exclusive jurisdiction of the courts of the People's Republic of China.

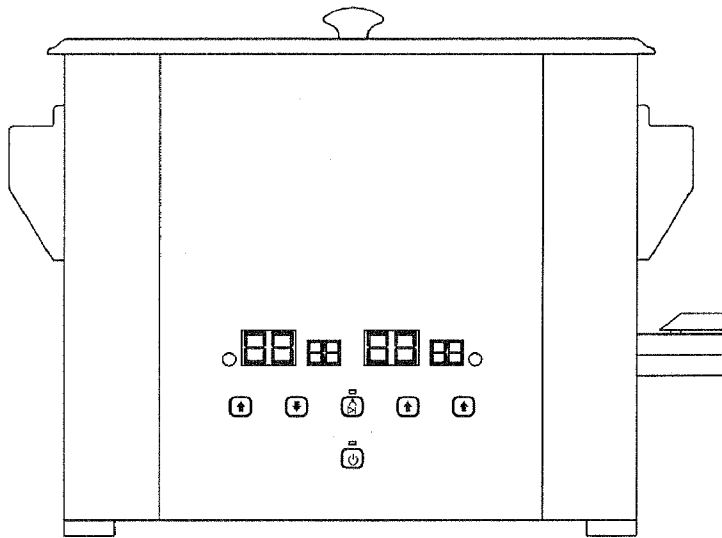

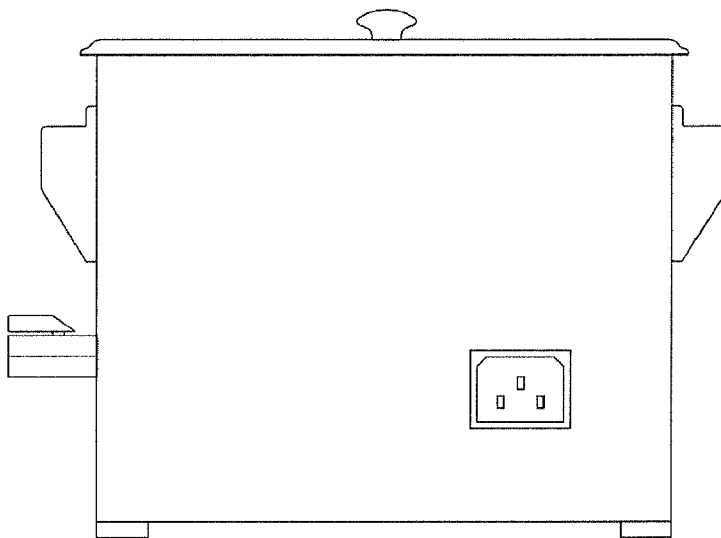

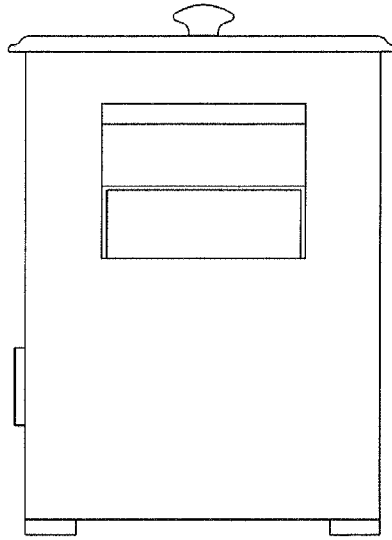

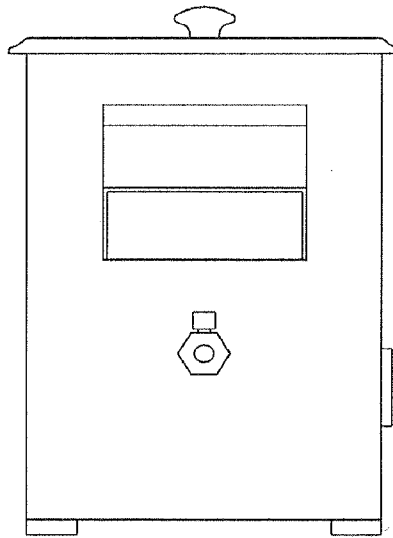

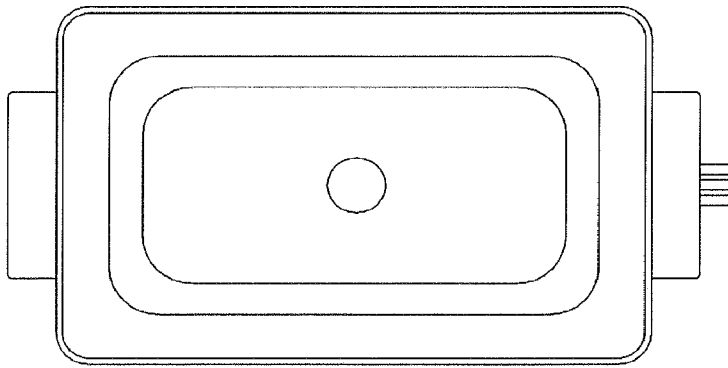

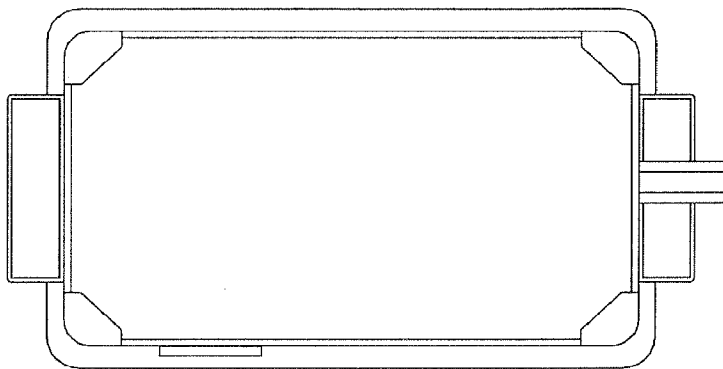
