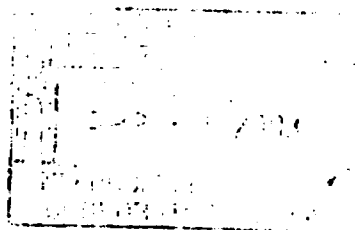
- A. **Name of Limited Liability Company:** MANGIA ONDA CO., LLC.
