ASSIGNMENT

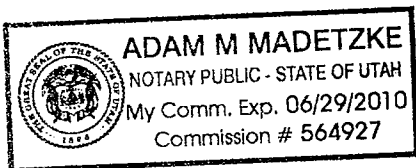

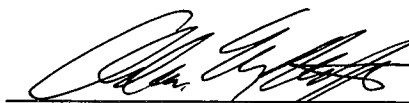
