ASSIGNMENT

WHEREAS, Frank C. 

A, B and C and incorporated by reference) Assignor has sold, assigned and transferred, and by these presents does sell, assign and transfer unto said Assignee, its successors or assigns, the entire right, title and interest to the US Patents, and to all divisions, continuations, or renewals thereof, all Letters Patent which have been granted therefrom, and all reissues or extensions of the US Patents; and Assignor does hereby authorize and request the Commissioner of Patents and Trademarks to recognize the Assignee as the assignee of the entire right, title and interest in and to the same, for the use of the Assignee, its successors and assigns.

AND, for the consideration aforesaid, Assignor does hereby agree that Assignor and Assignor's executors, persons holding power of attorney, and legal representatives will


make, execute and deliver any and all other instruments in writing including any and all further application papers, affidavits, assignments and other documents, and will communicate to said Assignee, its successors and representatives all facts known to Assignor relating to the US Patents and the history thereof and will testify in all legal proceedings and generally do all things which may be necessary or desirable more effectually to secure to and vest in said Assignee, its successors or assigns the entire right, title and interest in and to the US Patents hereby sold, assigned and conveyed, or intended so to be.

AND, furthermore Assignor covenants and agrees with said Assignee, its successors and assigns, that no assignment, grant, mortgage, license or other agreement affecting the rights and property herein conveyed has been made to others by Assignor or by any other person, that no person (other than Assignee) claims security interest in the US Patents, and that full right to convey the same as herein expressed is possessed by Assignor.
