# PATENT ASSIGNMENT

This Assignment is made the 21 day of June 2006 by and between

**AGENCE FRANCAISE DE SECURITE SANITAIRE DES ALIMENTS**, a public administrative organization of France, whose principal place of business is at 27-31 avenue du General Leclerc, BP-19, 94700 Maisons-Alfort Cedex, Paris, France (hereinafter referred to as **AFSSA**), represented by its Directrice générale, Dr. Pascale Briand

(formerly at 23, Avenue de General De Gaulle, F-94701 Maisons-Alfort, Paris, France),  
an organization formerly operating under the name of Center National D'Etudes Veterinaires Et Alimentaires (hereinafter **CNEVA**)

And

**Wyeth**, a corporation organized and existing under the laws of the State of Delaware, United States of America, whose principal place of business is at Five Giralda Farms, Madison, New Jersey 07940, United States of America (hereinafter referred to as **Wyeth**)

WHEREAS:

AFSSA, is the successor in interest of an agency formerly operating under the name CNEVA with respect to options rights and properties including specifically and without limitation the "Afssa Know-How" and the "Purchased Patent Assets", and is the registered owner of the entire right, title and interest in the patents (the "Patents") and patent applications (the "Applications"), together with all domestic and foreign equivalents thereto, details of which are set out below

PURSUANT to an agreement dated December 31, 2002 between AFSSA and Wyeth for the sale of certain assets, entitled AGREEMENT FOR PURCHASE OF PATENT RIGHTS WITH OPTION (the "Purchase Agreement") AFSSA has agreed to assign all such rights as it may have in the "Purchased Patent Assets", which includes the Patents and Applications, on the terms set out below;

Specifically the "Purchased Patent Assets" shall mean French patent application no. 97/15396, filed December 5, 1997, having French publication no. 2772047, and International Application No. PCT/FR98/02634, claiming priority from said French application, said international application having the International Publication No. WO 99/29871, and publication date of June 7, 1999, entitled "Circovirus Sequences Related To Piglet Weight Loss disease (PWD)", and any and all patents, certificates of invention, and applications for patents and certificates of invention, which are based on, relate to and/or claim priority from any of the foregoing applications; and any and all divisions, continuations, continuations-in-part, patents of addition, reissues, renewals, extensions, registrations, confirmations, re-examinations, provisional applications,

supplementary protection certificates or the like of such foregoing patents and patent applications, and any and all foreign equivalents and/or counterparts:

In pursuance of and subject to the Purchase Agreement and in consideration for the sums set out therein, such sums having been paid by Wyeth, AFSSA hereby assigns to the Wyeth the entire right, title and interest (including the right to sue for past infringement and/or recover pre-patent grant compensation) worldwide, in and to,

1. the Purchased Patent Assets including the Patents and the Applications and all rights, duties, liabilities, privileges and advantages attaching thereto to hold absolutely for the full term of the Patents, and any Patents issuing from the Applications, and with the intent that Wyeth shall as from the date hereof:

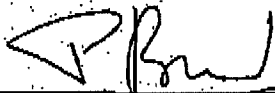
- a) be absolutely entitled to any patent granted on any of the Applications for the full term of such patents; and
- b) have the right to apply for, prosecute and obtain patents or like protection throughout the world for any invention embodied by any of the Applications, including the right to claim priority from the Applications; and

2. the Afssa Know-How as defined in the Purchase Agreement,

AFSSA shall also execute all documents and provide such information and assistance as Wyeth may request from time to time for the purpose of confirming to Wyeth all the right, title and interest in the Afssa Know-How, and in the Purchased Patent Assets which includes the Patents and Applications and to enable the Wyeth to prosecute the Applications to grant and to file and to protect the Applications and any patents issuing therefrom.

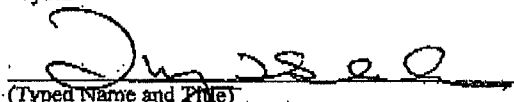
