
## ASSIGNMENT

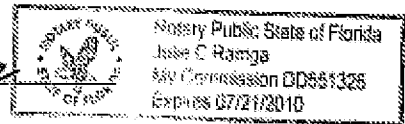

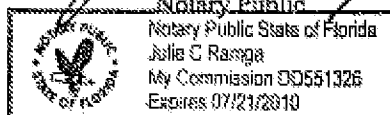
