ASSIGNMENT

WHEREAS, We, ERWAN BOUROULLEC, residing at 23 Rue du Buisson, 75010 Saint-Louis, France and RONAN BOUROULLEC, residing at 23 Rue du Buisson, 75010 Saint-Louis, France, have invented a new original and ornamental design for a FAUCET for which we have made application for Letters Patent of the United States of America; and

WHEREAS, HANSGROHE AG, a German corporation, having its office and a principal place of business in the City of Schiltach, Country of Germany, desires to acquire the entire right, title and interest in and to said invention;

FOR SAID CONSIDERATIONS, we hereby covenant and agree that we are the owner of the full title herein assigned and have the right to assign the same, and agree that we will communicate to said corporation or its representatives, any facts known to us respecting said invention or inventions and testify in any legal proceedings relating thereto when called upon, and will sign all instruments and documents and render such assistance which in

the judgment of said corporation is necessary to vest in it and protect the legal title sought to be assigned.
