PATENT ASSIGNMENT

THE PATENT IS SOLD TO BUYER ON AN "AS IS," "WHERE IS" BASIS AND EXCEPT AS MAY BE EXPRESSLY SET FORTH IN THE PURCHASE AGREEMENT, NEITHER SELLER NOR ITS AGENTS MAKE, AND BUYER HEREBY WAIVES, ANY WARRANTY, AGREEMENT OR REPRESENTATION OF ANY KIND OR NATURE, EXPRESS OR IMPLIED, AS TO THE PATENT, INCLUDING BUT NOT LIMITED TO ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

This Assignment may be filed and recorded as necessary to provide notice of the assignment contemplated hereby including, but not limited to, recordation in the records of the United States Patent and Trademark Office.

This Assignment shall be governed by, and construed and enforced in accordance with, the laws of the State of New York, without giving effect to principles of conflicts of laws. This Assignment may be executed in one or more counterparts, each of which will be deemed an original, and all of which will constitute one and the same agreement. Facsimile signatures or signatures delivered by email in .pdf or similar format shall be deemed original signatures for purposes of this Assignment.
