WHEREAS I, **MATTHIAS KULLA**, a German citizen residing at Leonberg, Germany, have invented certain new and ornamental improvements in an

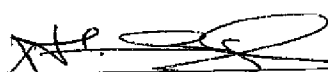

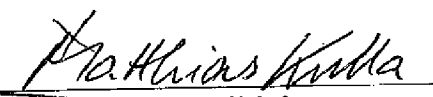
for which an application for Letters Design Patent of the United States of America was executed on the date of execution of this assignment;

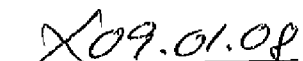
