ASSIGNMENT

WHEREAS, Satish D. Savant, residing at Peoria, Illinois, hereinafter referred to as ASSIGNOR, has invented a new and useful

ONE-PIECE TERMINAL BLOCK ASSEMBLY

2. At the request and expense of ASSIGNEE, ASSIGNOR agrees to communicate to ASSIGNEE any facts known respecting said invention, to execute all papers necessary to file any application on said invention necessary or desirable to aid ASSIGNEE in obtaining and enforcing proper protection for said invention in the United States of America and any foreign country.


