ASSIGNMENT

WHEREAS, We, OLIVIER WÜST, a citizen of Switzerland residing at GLADIOLENSTRASSE 29, CH-8472 SEUZACH, SWITZERLAND; and DR. And we hereby agree, at the expense of ASSIGNEE, to testify in any legal proceedings, sign all lawful papers, execute all divisional, continuation, continuation-in-part, reissue, and substitute applications, make lawful oaths and declarations, and generally do everything possible to vest title in ASSIGNEE and to aid ASSIGNEE to obtain and enforce proper protection for said invention in all countries.

And we hereby agree to transfer a like interest, upon the request of said ASSIGNEE, its successors, assigns and legal representatives, and without further remuneration, in and to any improvements, and applications for patent based thereon, growing out of or related to the said
