ASSIGNMENT

WHEREAS, Theodore B. Pasquale, a citizen of the United States of America, residing at 12610 Riata Trace Parkway, #512, Austin, Texas 78727; Benjamin A. 
Assignment. Assignors authorize the attorney or agent who files the patent application first referenced above to fill in the U.S. Application Serial No. and filing date above, if required.






