**PISTON WITH A SKIRT HAVING OIL FLOW SLOTS AND METHOD OF CONSTRUCTION THEREOF**


which is set forth in an application for Letters Patent in the United States having the attorney docket number (HD-40953; HD-41532/710240-4323) and executed on even date herewith;
