**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY RIGHTS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY RIGHTS** ("Termination and Release") is made November 24, 2009 by **SOVEREIGN BANK** ("Sovereign Bank"), a United States Financial Institution with a place of business at 1500 Market Street, Centre Square West, 25th Floor, Philadelphia, Pennsylvania 19102, to confirm the satisfaction and grant back of certain security interests in intellectual property formerly granted to Sovereign Bank by **INFOLOGIX, INC.**, a Delaware corporation ("InfoLogix"), **INFOLOGIX SYSTEMS CORPORATION**, a Delaware corporation (formerly known as Info Logix, Inc., a Delaware corporation) ("ISC"), **INFOLOGIX-DDMS, INC.**, a Delaware corporation ("DDMS"), **OPT ACQUISITION LLC**, a Delaware limited liability company ("Opt"), and **EMBEDDED TECHNOLOGIES, LLC**, a Delaware limited liability company ("Embedded") (together with InfoLogix, ISC, DDMS, and OPT collectively referred to herein as "Grantors" and individually as "Grantor").

WITNESSETH:

WHEREAS, the Grantors, or one or more of Grantors, entered into an agreement with Sovereign Bank that included the grant of a security interest recorded in the United States Patent and Trademark Office ("USPTO") on March 21, 2006 at Reel 017341, Frame 0529 against certain US patents and other intellectual property that had been pledged by Grantors as collateral security for the payment and performance of certain obligations of the Grantors to Sovereign Bank;

WHEREAS, Sovereign Bank terminated, released, and discharged its said security interest in the Patent Collateral (as defined below) in a **TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS RIGHTS** dated April 30, 2008, which was recorded with the USPTO on August 6, 2008 at Reel 021339, Frame 0567;

WHEREAS, the **TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS RIGHTS** dated April 30, 2008, recorded with the USPTO on August 6, 2008 at Reel 021339, Frame 0567, omitted to expressly release the security interest as to certain intellectual property encompassed by the grant of a security interest recorded in the United States Patent and Trademark Office ("USPTO") on March 21, 2006 at Reel 017341, Frame 0529;

WHEREAS, Sovereign Bank desires to terminate and release the entirety of its security interest as to all rights and property pledged by Grantors as collateral security, including all of the Intellectual Property Collateral as defined below;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Sovereign Bank hereby agrees as follows:

1. Definitions.

The term "Patent Collateral" as used herein, shall mean all of the Grantor's right, title, and interest of every kind and nature as of the date hereof in each of the Grantor's patents (including, without limitation, those items listed in Schedule A hereto).

The term "Intellectual Property Collateral" as used herein, shall mean all of the Grantor's right, title, and interest of every kind and nature as of the date hereof in each of the Grantor's patents, trademarks, copyrights, licenses, and know how (including, without limitation, those items listed in Schedule B hereto) that are or may be subject to the grant of a security interest recorded in the United States Patent and Trademark Office ("USPTO") on March 21, 2006 at Reel 017341, Frame 0529.


2. Release of Security Interest.

Sovereign Bank hereby terminates, releases, and discharges its security interest in the Intellectual Property Collateral as well as any all rights secured by the INTELLECTUAL PROPERTY SECURITY AGREEMENT dated March 16, 2006 without representation, warranty, or recourse of any kind or nature.
