RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made as of the 30 day of November 2009, by and between QSPED SEMICONDUCTOR INC., a Delaware corporation, formerly known as Lovoltech, Inc.
