ASSIGNMENT AND AGREEMENT
Joint Inventors

WHEREAS, Michael Mason, County of Chesterfield, State of Virginia, and Paul A. 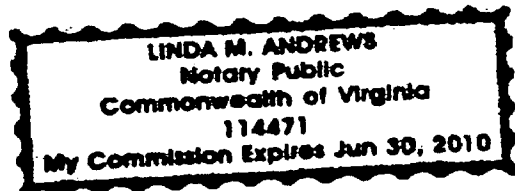


