## ASSIGNMENT

WHEREAS, we, **Claude L. Bertin**, residing at 514 Sawgrass Bridge Road, Venice, Florida 34292, **C. 3. 4. 5. 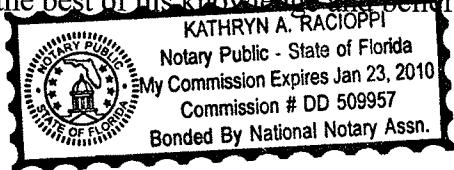
