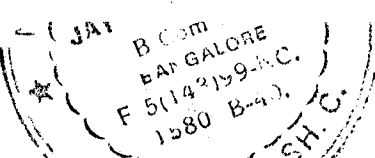
ASSIGNMENT

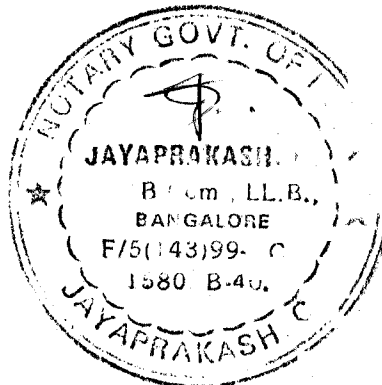

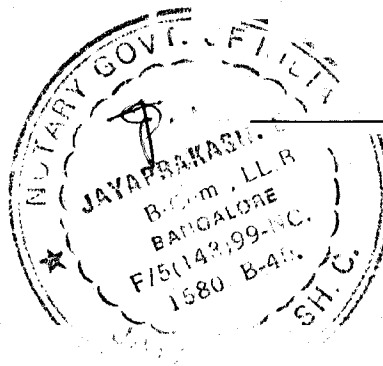

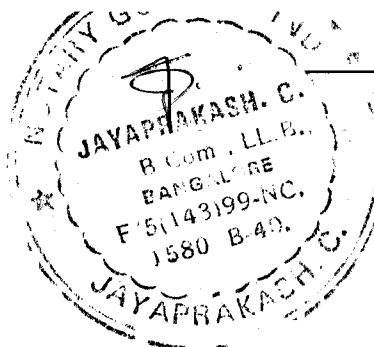
