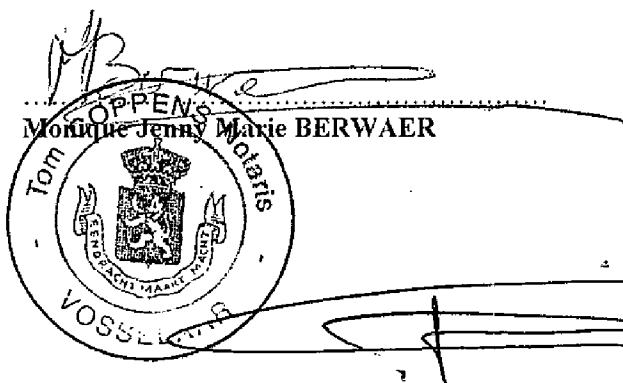

I acknowledge that this obligation includes the duty to execute, in a timely manner, any Declaration and Power of Attorney that may be necessary in the prosecution of applications relating to said Inventions in the United States or elsewhere.
