Pursuant to Title 8, Section 251 of the Delaware General Corporation Law, the undersigned corporation executed the following Certificate of Merger:

FIRST: The name of the surviving corporation is Micro Focus (US), Inc, a Delaware corporation, and the name of the corporation being merged into this surviving corporation is NetManage, Inc., a Delaware corporation.

SECOND: The Agreement and Plan of Merger (the "**Agreement**") has been approved, adopted, certified, executed and acknowledged by each of the constituent corporations pursuant to Title 8, Section 251 of the General Corporation Law of the State of Delaware.

THIRD: The name of the surviving corporation is Micro Focus (US), Inc., a Delaware corporation.
