Agree that, when requested, without charge to but at the expense of said Assignee, its successors, assigns, and legal representatives, to carry out in good faith the intent and purpose of this assignment, the undersigned will, for all countries, execute all divisional, continuing, substitute and renewal, reissue and all other patent applications on any and all said inventions, developments, said Assignee, its successors, assigns, and legal representatives, all facts known to the undersigned relating to said invention, developments, improvements and the history thereof; testify in all legal proceedings, and generally do everything possible which said Assignee, its successors, assigns, and representatives shall consider desirable for aiding in securing, maintaining and enforcing proper patent protection for said inventions, developments and improvements, and all vesting title to said improvements, inventions and developments and all applications for patents and all patents on said inventions, developments and improvements, in said Assignee, its successors, assigns and legal representatives.
